# Chief's Report

Chief Patterson discussed August activities including 191 calls for service and a fire deployment to the 2620 Fire. Olympic Ambulance response was discussed.

2025 PENCOM fees were increased \$9,200 instead of \$23,000.

Chief Patterson discussed moving to a new scheduling software called First Due.

A special meeting with Fire District 4 was suggested to discuss their new fire station construction.

The Clallam County Fire Chiefs Association meetings have been suspended until further notice due to lack of participation. The group may be reactivated in the future.

### **Unfinished Business:**

1. Citizen Advisory Committee: Discussion

The Board was in consensus on putting a citizen advisory group together. Further discussion to determine the scope and implementation. Chief Patterson asked the Board to hold off on implementation of the project until 2025. Tabled until October.

2. Residential Knox Box Program Policy: Discussion

Policy 4.4 was discussed and changes were suggested. Tabled until October when a revised policy will be presented to the Board.

3. Policy 12.3 Controlled Medications policy amendment: Discuss and take action

Policy 12.3 was discussed and changes suggested. Tabled until October when a revised policy will be presented to the Board.

4. Vehicle Exhaust Systems update: Discussion

No new information was available at the time of the meeting.

#### **New Business:**

1. Anaka Hughes Recognition

Volunteer Training Coordinator Anaka Hughes was recognized for her work with Camp Blaze, a leadership firecamp for young women. The Board and Chief Patterson expressed their admiration and thanked her for her work.

2 Proclamation 2024-02 Fire Prevention Week: Discuss and take action

**Board Action**: Commissioner Huff made a motion to approve Proclamation 2024-02, Fire Prevention Week. Commissioner Hopf provided a second to the motion, and with no discussion, the motion carried unanimously.

3. 2025 Budget: Discussion

Two special meeting dates were set to discuss the 2025 budget: Wednesday, October 9, 2024 at 10 AM and Tuesday, November 12, 2024 at 10 AM. Capital purchases were discussed including a pickup truck and air compressor for station 21. These purchases were budgeted in 2024 but not purchased.
